DHL lost the courier, causing losses to Company. XY Company was demanding the actual losses suffered by it. DHL made its customers sign a form containing the terms. Clause 5 of the terms of courier had limited the liability of the DHL in the event of loss of courier to \$100. It is apparent that the appellant (DHL) was negligent in not delivering the consignment and due to the deficiency in service, the consignment was lost. because of the negligence, loss has occurred to the complainant (XY Company).

(A) Discuss the type of damage do you think in the case?

(B) The loss has to be restricted as per the terms of the contract. Discuss your point of view.
